



Photography Contract

1. Exclusive Photographer. FOTOGRAE SERVICES LIMITED shall be the exclusive photographer(s) retained by the Client for the purpose of photographing the wedding ("the event") at _____ venue on _____ date. Family and friends of the Client shall be permitted to photograph during the wedding as long as they shall not interfere with the photographer's duties and do not photograph poses arranged by the photographer.

2. Deposit and Payment. The Client shall make a 50% deposit to retain FOTOGRAE Services Limited to perform the services specified herein. The Client shall pay the balance due on or before the event date.

3. Refund Policy. Once payment has been received, for services or photo reprints / enlargements, no refund will be issued for any reason.

4. Photographic Materials. All photographic materials, including but not limited to photographs, negatives, transparencies, proofs, and previews, shall be the exclusive property of FOTOGRAE Services Limited. Clients will receive a proof set and high-resolution proof CD/DVD-rom as part of all the packages FOTOGRAE Services Limited offers. All images are copyrighted and FOTOGRAE Services Limited asks that no prints be reproduced for any reason unless written permission from FOTOGRAE Services Limited is granted. Should the Client require high-resolution Proofs, this will be negotiated under a separate agreement and the terms governing the release of these images would be determined therein.

5. Copyright and Reproductions. FOTOGRAE Services Limited shall own the copyright of all images created and shall have the exclusive right to make reproductions. FOTOGRAE Services Limited shall only make reproductions for the Client, Client's family and friends or for the Companies portfolio, self-promotions, not limited to advertisements in magazine and newspaper, website promotion including advertisements for www.fotograe.com, said website's photo galleries, entry in photographic contests or art exhibitions, editorial use, or for display within or on the outside of FOTOGRAE Services Limited's studio. If FOTOGRAE Services Limited desires to make other uses, FOTOGRAE Services Limited shall not do so without first obtaining the written permission of the Client.

6. Client's Usage. The Client is obtaining prints for personal use only, and shall not sell said prints or authorize any reproductions there of by any parties with out written permission from FOTOGRAE Services Limited.

7. Failure to Perform. If the Photographer cannot perform this Agreement due to a fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness, then FOTOGRAE Services Limited shall return any amount paid to the Client but shall have no further liability with respect to the Agreement. This limitation of liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of FOTOGRAE Services Limited. FOTOGRAE Services Limited shall not be liable for any amount in excess of the retail value of the Client's package price.

8. Photographer. FOTOGRAE Services Limited may substitute photographers to take the photographs in the event of an agreed upon photographer's illness or of scheduling conflicts. In the event of such substitution, FOTOGRAE Services Limited warrants that the photographer taking the photographs shall be a competent professional.

9. FOTOGRAE Services Limited's Standard Price List. The charges in this Agreement are based on FOTOGRAE Services Limited's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.

10. Misc. This Agreement incorporates the entire understanding of both parties. Any modifications of this Agreement must be in writing and signed by all parties involved. Any waiver of a breach or default hereunder shall not be deemed a waiver of a subsequent breach or default of either the same provision or any other provision of this Agreement. The laws of Trinidad and Tobago shall govern this Agreement.
